1. This Invitation for Bids is issued following the publication of the General Procurement Notice (GPN) for this project, which was published on the Inter-American Development Bank's website under publication number IDB-P1175095 on 04/23.
2. Suriname has received financing from the Inter-American Development Bank (IDB) to partially finance the cost of the Water Supply Modernization Program and intends to apply part of the proceeds to payments under the Contract detailed in this Request for Bids.
3. The N.V. Surinaamsche Waterleiding Maatschappij invites eligible bidders to submit sealed bids for the Purchase of pipes, fittings and accessories for PVC Ø315 mm raw water line and PVC Ø400 mm transmission main.
4. The Request for Bids (RFB) will be conducted through the International Competitive Bidding (ICB) process as specified in the [**Inter-American Development Bank's Procurement Policies for the Procurement of Goods and Works**](#), and is open to all bidders from eligible countries, as defined in the Bidding Documents. Refer to Section IV. Eligible Countries for the list of eligible countries.

5. The qualification requirements include:
 - Letter of Bid prepared in accordance with ITB 12;
 - Price Schedules: completed in accordance with ITB 12 and ITB 14;
 - Bid-Securing Declaration, in accordance with ITB 19.2;
 - Authorization: written confirmation authorizing the signatory of the Bid to commit the Bidder, in accordance with ITB 20.3; This authorization MUST be accompanied by an extract from the Chamber of Commerce and Industry;
 - Qualifications: documentary evidence in accordance with ITB 17 establishing the Bidder's qualifications to perform the Contract if its Bid is accepted;
 - Bidder's Eligibility: documentary evidence in accordance with ITB 17 establishing the Bidder's eligibility to bid;
 - Eligibility of Goods and Related Services: documentary evidence in accordance with ITB 16, establishing the eligibility of the Goods and Related Services to be supplied by the Bidder;
 - Conformity: documentary evidence in accordance with ITB 16 and 30, that the Goods and Related Services conform to the bidding document; and any other document required in the BDS.

6. A Margin of Preference for national contractors or joint ventures will not be granted. No Best and Final Offer (B.A.F.O.) nor Negotiation will be applied.

8. Bids must be delivered to the address specified below no later than **Friday, February 6, 2026 at 12.00 hours Suriname Time**. Electronic submissions will not be permitted. Late bids will be rejected.
9. Bids will be opened physically in the presence of bidders' representatives who wish to attend in person, at the address indicated below on **Friday, February 6, 2026 at 12.15 hours Suriname Time**.
