Contract Scope Summary: The objective of this project component is to increase the availability of water supply services in district Wanica by upgrading and expanding the water production capacity and infrastructure of Helena Christina with 240 m³ /h, together with an additional improvement of 120 m³/h in the current process to reduce the current risk of operating failure due to heavy overburden. By 2028 this project should be able to supply potable water to an additional 3,720 households.
